So, in this regard Head of the Departments/Directors/Coordinators of all the Traditional/Self-Financing/Vocational Courses are hereby requested to kindly ask the concerned faculty members of their respective Departments to motivate all the **Under Graduate Students (Academic Session: 2021-2024 and 2022-2025)** and **Post Graduate Students (Academic Session: 2021-2023 and 2022-2024)** of their respective departments to fill up their complete details as required in the **Google Form** (link given below) for creating their **Academic Bank of Credit (ABC) ID** by the Examination Department. All the students are required to furnish their complete details **latest by 27.07.2023**.

All the students those who have already filled the form and if their ABC ID (can be checked from their digilocker account) has not been created are again required to fill the google form with correct details.

Mandatory fields which all the students are required to fill properly and correctly in the google form are as follows:

1. Candidate Name (as mentioned in their Aadhar Card)
2. Date of Birth (strictly in the format DD-MM-YYYY e.g. 10-08-2002)
3. Gender (Male/Female/Transgender)
4. Aadhar Number (12 Digits without space between digits)
5. Mobile Number (strictly which is linked to students' Aadhar Card)
6. Registration Number (as mentioned in the Registration Slip/Admit Card)
7. Examination Roll Number (as mentioned in the Admit Card)

Sir/Madam,

As you are aware that the workshop titled "Implementation of Academic Bank of Credits (ABC)," held on 12th May 2023 with all State & Private Universities of Jharkhand.

The workshop shed light on the importance and potential benefits of implementing the Academic Bank of Credits (ABC) within educational institutions through discussions, case studies, and practical examples.

Furthermore, as per the guidelines issued by UGC, Academic Institutions are required to speed up the creation of ABC ID's and upload the credit data of the students in their respective ABC accounts.

To monitor the progress of the implementation of ABC in HEI's of Jharkhand, a review meeting is scheduled on 14th July 2023 at 12:30 pm via video conferencing mode. The link for the same is attached below.

Following inputs are required for the review in the meeting.

1. Has ABC registration for the Institution been done?
2. How many students' ABC IDs have been created for 2021-2022 and 2022-2023 sessions?
3. What is the Count of ABC data uploaded through the NAD-Digi Locker portal?
4. By when the complete ABC data for the year 2021-2022 and 2022-2023 will be uploaded on ABC. Please provide a timeline for the same.
5. What steps have been taken for creating awareness among students?
6. Status on uploading of students' academic certificates/ legacy data for the past 10 years on the NAD-Digi Locker portal.

Kindly consider this as a priority and submit the above inputs by 12th July 2023 to the office of the undersigned and make sure to attend the meeting on 14th July 2023 with the concerned Nodal Officers.
