Technical bid of the parties shall be opened on the same day i.e., 17/03/2025 at 2:30 PM** in the presence of Bidder who wish to be present. The price bids of technically qualified parties shall be opened at a later date and the technically qualified parties shall be informed in advance about the opening of their price bid.
2. Intending Bidder should have valid registration with appropriate authorities for statutory taxes as applicable.
3. The intending Bidder should have satisfactorily completed similar works during last 03(Three) years ending 31.01.2025. Similar nature work means: - **“Civil works related to Building Construction”** only.
4. All the pages of the tender documents should be signed and stamped by bidders for their acceptance of all terms and conditions of the tender.
5. The envelope of the Technical Bid must contain Tender Fee and EMD.
6. All offers should be written in the English and price should be written in both, figures and words. The offer should be typed or written by ink pen or ball pen. **Offer in pencil will be ignored.**
7. University reserves the right to reject any or all the tenders without assigning any reason thereof and also not bound to accept lowest tender. Tenders not fulfilling the prescribed conditions or are found incomplete in any respect are liable to be rejected.
8. Canvassing, whether directly or indirectly in connection with tender is strictly prohibited and the tender submitted by the contractors who resort canvassing will be liable to be rejected summarily.
9. The subletting of work to anyone after agreement by the Contractor will be treated as breach of agreement and after receiving due information, the agreement will be cancelled and the contractor will be black listed.

1. The bidder must have valid registration of the Firm and along with Labour Licence.
2. The bidder should be an Income tax assesses (latest Income Tax return should be enclosed) and it should comply with the Indirect Tax also i.e. GST No.
3. The bidder must submit the Copy of the GST Registration and PAN.
4. **The bidder must submit the Tender Fee of ₹ 1,000/- (Rupees One Thousand Only) and EMD of ₹ 10,000/- (Rupees Ten Thousand Only) in the form of Demand Draft drawn from any nationalized bank in favour of "The Registrar, DSPMU" Payable at Ranchi.**
5. **Work Experience:** The intending Bidder should have satisfactorily completed similar works during last 3(Three) years ending 31.01.2025. Similar nature work means: - **"Civil works related to Building Construction"** only. The values mentioned above are inclusive of service tax/GST.
