- 14. The successful bidders need to submit the Security Deposit/ Performance Bank Guarantee of Rs. 57,000/- (Rupees Fifty Seven Thousand Only) in form of Bank Security/ DD etc in Favour of Registrar, DSPMU, Ranchi payable at Ranchi after issue of work order.

### **GENERAL RULES**
